I understand that R.I.S.E. Basketball cannot be held liable for any exposure to the COVID-19 virus caused by misinformation on this form or the health history provided by each player.

I agree to each statement above and release R.I.S.E. Basketball and any and all participants in this training/camp/clinic/event who can be proven to be truthful on this waiver from any and all liability for the unintentional exposure or harm due to COVID-19.
